MOTION TO SET A STATUS CONFERENCE



On April 4, 2012, the administrative law judge granted the Respondents' request to stay this proceeding due to Mr. Smoot's February 7, 2012 indictment by a Maricopa County Grand Jury. The ALJ also ordered that the Division file a motion to schedule a status conference upon any changes of the circumstances with respect to the Respondents.

Since the April 4, 2012 order granting the stay, the criminal case that was the subject of the Maricopa County Grand Jury indictment was dismissed without prejudice. The Division was also informed that the Arizona Attorney General will not pursue a criminal case against Smoot that would

1 have been based on the events that are the subject of the Notice in this case. In light of these
2 developments, the Division respectfully requests that this matter be set for a status conference.
