**PROCEDURAL ORDER**  
**APPROVING CONSENT TO EMAIL**  
**SERVICE**

**BY THE COMMISSION:**

On January 3, 2018, Stacey Champion filed a formal Complaint against Arizona Public Service Company (“APS”) with the Arizona Corporation Commission (“Commission”). The Complaint, signed by Ms. Champion, was submitted in the form of a Change.org petition including Ms. Champion’s name and the names of 425 other individuals characterized as customers of APS. No mailing addresses were provided for the individuals other than Ms. Champion.

On January 22, 2018, Stacey Champion filed a Consent to Email Service in this docket. Ms. Champion’s designated email address has been confirmed.

Because Ms. Champion has now completed all of the steps for approval of Consent to Email Service in this docket, it is appropriate at this time to approve Ms. Champion’s Consent to Email Service.

In Ms. Champion’s January 22, 2018, filing she included additional email addresses for individuals to whom Ms. Champion desires to have “service emails” sent as a courtesy. There are no names or physical addresses associated with the email addresses. It is the Commission’s understanding that Ms. Champion is not an attorney and does not represent any other party to this proceeding. All parties to this proceeding are subject to, *inter alia*, Arizona Supreme Court Rule 31, which prohibits legal representation of others by individuals not a member of the State Bar of Arizona, with specific exceptions. Consequently, Ms. Champion cannot consent to email service on behalf of any other party. The Commission’s process for Consenting to Email Service, however, allows parties who have

1 consented to service by email to request courtesy emails be sent to email addresses in addition to the  
2 verified email address. As a result, the email addresses provided by Ms. Champion have been added to  
3 the service list to receive courtesy copies. Parties wishing to consent to service by email should refer  
4 to the ordering paragraph below for more information on the process.

5 IT IS THEREFORE ORDERED that **Stacey Champion's consent to receive service of all**  
6 **filings** in this docket, including all filings by other parties (including Commission Staff), all Procedural  
7 Orders and Recommended Opinions and Orders/Recommended Orders issued by the Commission's  
8 Hearing Division, and all filings made by a Commissioner or the Commission's Executive Director,  
9 **via email sent to Stacey Champion's designated email address** rather than via U.S. Mail, is hereby  
10 **approved.**

11 IT IS FURTHER ORDERED that each party or prospective party shall **refer to the Procedural**  
12 **Order Regarding Consent to Email Service** issued in this matter on **January 10, 2018**, for additional  
13 information regarding the process to consent to service by email. Information regarding Consent to  
14 Email Service is also available on the Commission's website ([www.azcc.gov](http://www.azcc.gov)) by clicking on "I Want  
15 To" and then "Learn about Consenting to Email Service."

16 IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules  
17 31, 38, 39, and 42 and A.R.S. § 40-243 with respect to the practice of law and admission *pro hac vice*.

18 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or  
19 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at  
20 hearing.
