**RICHARD GAYER'S
STATUS REPORT**

Richard Gayer, a party to this Docket, hereby submits the Status Report required by the Procedural Order dated March 05, 2018.

1. The parties through their attorneys and in *pro per*, conferred telephonically during the afternoon of March 06, 2018. Participating were Thomas Loquvam and Melissa Kruger for APS, Adam Stafford for Stacey Champion, and Richard Gayer for himself.

2. The parties were unable to agree on anything of significance, including a comprehensive schedule.

3. The parties did agree that Stafford be given 60 days to continue performing some kind of preliminary review of documents, largely bills issued by APS to its customers.

4. Loquvam refused to answer Gayer's question regarding the validity of using the line item on APS's bills called "Cost of electricity used" to compare bills under the new and old and Transition rate structures. That line item includes *all* charges except taxes and fees.

5. However, Loquvam told Gayer that he was free to submit Data Requests, starting immediately.

1 6. Gayer is unlikely to oppose any scheduling suggested by Stafford.

2 7. Gayer will re-send to everyone on the Service List his unanswered and slightly revised
3 First Set of Data Requests, originally served via email on January 30, 2018 but ignored by APS.
