PROCEDURAL ORDER

BY THE COMMISSION:

On January 3, 2018, Stacey Champion filed a formal Complaint against Arizona Public Service Company (“APS”) with the Arizona Corporation Commission (“Commission”) (“Champion Complaint”). The Champion Complaint, signed by Ms. Champion, was submitted in the form of a Change.org petition including Ms. Champion’s name and the names of 425 other individuals characterized as customers of APS.

On February 12, 2018, Mr. Adam Stafford filed a Notice of Appearance of Counsel on behalf of Ms. Champion.

Mr. Richard Gayer, a signatory to the petition and an APS customer, and Mr. Warren Woodward have been granted intervention.

By Procedural Order dated April 16, 2018, the matter was set for hearing to commence on September 25, 2018, and other procedural guidelines were established.

On August 31, 2018, Ms. Champion filed a Request for Pre-Hearing Conference to discuss the number of witnesses and time for testimony in order to avoid unnecessary or cumulative evidence at the hearing.

A Pre-Hearing Conference to discuss witness scheduling and preparation of exhibits will promote an orderly and efficient hearing process.

IT IS THEREFORE ORDERED that the pre-hearing conference in this matter shall commence on Monday, September 17, 2018, at 10:30 a.m., or as soon thereafter as is practical, at

1 **the Commission's offices, 1200 West Washington, Phoenix, Arizona 85007.**

2 IT IS FURTHER ORDERED that each party or prospective party shall **refer to the Procedural**
3 **Order Regarding Consent to Email Service** issued in this matter on **January 10, 2018**, for additional

5 Email Service is also available on the Commission's website (www.azcc.gov) by clicking on "I Want
6 To" and then "Learn about Consenting to Email Service."


7 IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance
8 with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Arizona
9 Supreme Court Rule 42). Representation before the Commission includes the obligation to appear at
10 all hearings, procedural conferences, and Open Meetings for which the matter is scheduled for
11 discussion, unless counsel has previously been granted permission to withdraw by the Administrative
12 Law Judge or Commission.

13 IT IS FURTHER ORDERED that all parties must comply with Arizona Supreme Court Rules
14 31, 38, 39, and 42 and A.R.S. § 40-243 with respect to the practice of law and admission *pro hac vice*.

15 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized
16 Communications) applies to this proceeding and shall remain in effect until the Commission's Decision
17 in this matter is final and non-appealable.

18 IT IS FURTHER ORDERED that the Administrative Law Judge may rescind, alter, amend, or
19 waive any portion of this Procedural Order either by subsequent Procedural Order or by ruling at
20 hearing.
