**RICHARD GAYER'S

STAFF'S MOTION TO  
EXTEND TIME TO FILE**

Richard Gayer, a party to this case, hereby submits his Opposition to Staff's Motion to Extend Time to File Testimony and Staff Report.

Staff, having waived and precluded its ability to participate in this case as a neutral party by signing the Settlement Agreement in favor of APS, should not be granted any additional time. Staff has already enjoyed 76 days since June 29, 2018, the day it filed its intention to participate in this case, through Friday September 14 so far, to prepare its papers. In this unusual situation, Staff is not even a proper party to this case. Staff is doing its best to extend proceedings in this case beyond the November elections, apparently to protect the interests of most of the current Commissioners.

In fairness to Stacey Champion who is supporting her attorney with some of her own money, Chairman Forese should direct Staff to withdraw immediately.
