**STAFF'S RESPONSE TO  
COMPLAINANT'S REQUEST FOR AN  
EXTENSION OF FILING DEADLINE**

The Utilities Division of the Arizona Corporation Commission (“Staff”) has reviewed Complainant Stacey Champion’s (“Complainant”) request for an extension of the November 16, 2018 filing deadline for Reply Briefs in this matter.

Complainant is asking that the deadline for filing Reply Briefs be extended from November 16, 2018 to December 14, 2018, or approximately one month. Complainant states that she needs more time to review Arizona Public Service Company’s (“APS”) bill impact analysis for May to August 2018 and the educational materials provided by APS in response to Commissioner Dunn’s letter. Staff notes that Champion’s complaint was filed on January 3, 2018, and that she has repeatedly objected to any requests by Staff for an extension of filing dates regardless of the hardship on Staff. In support of her previous objections, she has claimed that any extension of the time would be extremely prejudicial to her because of the time, expense and burden this proceeding has placed upon her. For this reason, Staff is puzzled by her request now for a one-month delay to submit Reply Briefs in this matter.


