
UPDATE ON STATUS REGARDING
SETTLEMENT DISCUSSIONS AND
PROPOSED PROCEDURAL SCHEDULE

11 A Procedural Order was issued on October 25, 2018, for Complainant Lori Ochmanski of Intel Lock –
 12 Tucson Locksmith (the ‘Complainant’) and Qwest Corporation d/b/a/ Centurylink (‘Centurylink’) to discuss
 13 and submit a joint proposed schedule for hearing requirements in the event the Parties were unable to
 14 reach a settlement, and Centurylink never completed the repairs to the phone. The parties were unable
 15 to reach a settlement as of December 7, 2018.

17 The proposed schedule by the Complainant is as follows:

- 18 • 12/10/18 Amending the pleadings if the Parties determine amendments are necessary after
- 19 discussing the proper real party-in-interest;

- 21 • 12/11/18 Complainant to submit a proposed list of witnesses, including a summary of their
- 22 testimony, and a proposed list of exhibits;

- 24 • 12/17/18 Discovery deadlines, if it is necessary;

- 26 • 12/21/18 Final submission of all pre-filed testimony and exhibits;
- 27
- 28 • 12/22/18 Final objection to any pre-filed testimony and exhibits;

- 30 • 12/26-28/18, and 1/3-4/19 if needed; Hearing date request and request 3-5 days.
