**PROPOSED PROCEDURAL SCHEDULE**

11 The Miscellaneous Motion granted on December 10, 2018, allowed for an extension of time for Qwest  
 12 Corporation d/b/a/ Centurylink ("Centurylink") to coordinate a schedule for hearing proceedings with Lori  
 13 Ochmanski of Intel Lock – Tucson Locksmith (the 'Complainant') and to file a joint proposed schedule by  
 14 December 17, 2018.

16 The schedule proposed by the Complainant would allow more time as instructed and is as follows:

December 18, 2018	Complainant file update Real-Party in Interest.
December 31, 2018	Discovery, Centurylink to turn over copy of the repair tickets generated, all internal repair tickets, recordings of Complainant made for quality assurance, and all files associated with phone account(s) through time.
January 16, 2019	Complainant to file final pre-file testimony/amended complaint, witness list and exhibits.
January 25, 2019	Centurylink to file any objections or motions in limine to Complainant's final

	testimony/amended complaint, witness list, or exhibit based on it's argument that Complainant is seeking damages outside scope of Commission's jurisdiction.
February 1, 2019	Complainant to respond to Centurylink objections/motions in limine regarding Commission's jurisdiction to award damages.
February 7, 2019	Centurylink to file pre-file testimony, exhibits.
February 14, 2019	Complainant to file rebuttal testimony, exhibits.
February 21, 2019	Deadline for pre-hearing motions, including objections to exhibits, testimony.
February 27 (-28 <sup>th</sup> , if needed)	Hearing.
March 1, 2019	Post-Hearing Briefing.

1 The alternate schedule proposed by Counsel for Centurylink is as follows:

March 7, 2019	CenturyLink to file pre-file testimony, exhibits.
March 21, 2019	Complainant to file rebuttal testimony, exhibits.
March 28, 2019	Deadline for pre-hearing motions, including objections to exhibits, testimony.
Mid-April	Hearing.
Post-Hearing Briefing	TBD at hearing, but if briefing is done, one round of simultaneous briefs no later than 14 days after the end of the hearing.

2 The position of the Complainant is to provide a timely schedule to complete the hearing requirements  
 3 and hearing.


